C. BIDDING QUOTATION CONDITIONS:

- 1. All suppliers of good & services are urged to register in the National Treasury web based Central Suppliers Database with Effect from 1 July 2016.
- 2. As per National Treasury Instruction No.4 A of 2016/2017 National Treasury Supplier Database, organs of state must ensure that suppliers awarded business with the State are registered on the CSD prior to award letter/purchase order/signed contract being issued.
- 3. According to the amended Codes of Good Practice, an *Exempted Micro Enterprise* (*EME*) is only required to obtain a sworn affidavit or a certificate issued by Companies Intellectual Property Commission (CIPC) confirming their annual turnover of R10 million or less and level of Black ownership to claim BEE points.

- 4. According to the amended Codes of Good Practice, Qualifying Small Enterprise (QSE) is only required to obtain a sworn affidavit or a certificate issued by Companies Intellectual Property Commission (CIPC) confirming their annual turnover of R50 million or less and level of Black ownership to claim BEE points.
- 5. A trust, consortium or joint venture will qualify for points for the BBBEE status level as a legal entity, provided that the entity submits their consolidated BBBEE status level certificate. If a bidder does not submit a certificate substantiating the BBBEE status level of contribution and/or Affidavit or is a non-compliant contributor, the bidder will not be disqualified in the bidding process but score zero (0) points for BBBEE.
- 6. Bidders by joint ventures are to be accompanied by the Document Formation of the joint venture, duly registered and authenticated by a Notary Public or other official deputized to witness sworn statements. This document must define precisely the conditions under which the joint venture will function, the period for which it will function, the persons authorized to represent and obligate it, the address for correspondence, the participation of several firms forming the joint venture and any information necessary to permit a full appraisal of its functioning, including a clause to the effect that the members of the joint venture are jointly and severely bound.
- 7. BBBEE Non-compliant bidders will not be rejected, but will forfeit ten (10) points designated for Broad Based Black Economic Empowerment.

- 18. In the event of a mistake having been made on the pricing schedule, it shall be crossed out in ink and be accompanied by full signature at each and every alteration. The Municipality reserves the right to reject the bid if corrections are not made in accordance with the above.
- 19. The lowest or any quotation will not necessarily be accepted, and Mogale City reserves the right to accept a quotation in whole or in part.
- 20. The Municipality reserves the right to appoint and not to appoint.
- 21. The validity period for this quotation is sixty (60) days. All Price(s) quoted must be valid for at least sixty (60) days from date of offer.
- 22. The Municipality reserve the right to negotiate a fair market related price with recommended bidders after a competitive bidding process or price quotations.
- 23. All quotation prices must be inclusive of VAT for all registered VAT vendors.
- 24. All bid prices must be in RSA currency and inclusive of VAT.
- 25. Bids must be submitted in original, a copy of original and electronically on a USB which is PDF formatted.

	1. INTRODUCTION AND BACKGROUND
	The HIV and AIDS Management Section is located within the Community Services Department under Social Development Division. The section specializes on Ward Based door to door HIV/AIDS programme. This is one of the Government's preventative approaches used nationally to empower people about the epidemic of the virus and to them in turning knowledge into action. There are 114 ward-based volunteers who are conducting education on HIV/AIDS in the 39 Wards of Mogale City. Through the door-to-door community education programme, the municipality has been able to reach out to 211 347 people during the 2019/ 2020 financial year.
	The section plans to train seventy (70) educators/volunteers in Peer Education Accredited training. It is a twelve (12) months course aimed at equipping learners, giving them an opportunity and an exposure in learning more about community dynamics. It will also empower the educators/volunteers with relevant skills so that they can apply for better employment opportunities at Social Development, Department of Health, and other funded NGO's. The accredited training serves as an exit plan from the programme since some of the educators/volunteers have more than 10 years in the programme and receiving stipend.
	2. SCOPE OF WORK The successful service provider will be expected to conduct accredited training on Peer Education Accredited training to Mogale City Local Municipality ward-based educators/volunteers. The training should provide theoretical knowledge on basic counselling and provide practical learning for the learners. At the end of the training, the service provider is expected to assess the performance of the trainees and provide a competency certificate.
	The successful training service provider will be expected to conduct training to seventy (70) educators/volunteers of Mogale City Local Municipality (where they would be required to apply their acquired skills and knowledge after the training).

PROJECT COSTING

In terms of the Municipality's procurement procedures proposals are evaluated based on a total cost or value for money (in addition to other criteria). As such potential service providers are required to prepare a plan of work with clear cost estimates based on the information provided in this Terms of Reference, as this will facilitate a comparison across proposals. The plan of work is to include detailed tasks to be carried out, how long it will take to complete the tasks and disbursements.

All assumptions made in preparing the cost estimate must be clearly indicated in the proposal.

TECHNICAL EVALUATION FOR PROPOSALS

- The below mentioned criteria regarding Functionality is required for responsiveness and therefore eligibility for the next stage of evaluation. This is done to determine the ability of each bidder to successfully execute the contract according to specifications.
- Non-compliant bidders will be rejected after this phase and not continue to price scoring.
- These criteria shall only determine whether a tender will further be evaluated and will not influence the points scored on Price.
- If any total minimum score for any criteria is zero rated, the tenderer will be rejected, even if the required 18 out of 25 points are achieved
