If any criterion is rated zero points, the bidder will be rejected, even if the required 28 out of 45 points are achieved. All information and particulars necessary to properly evaluate the tender must be furnished on the submission. Incomplete particulars and documents required to substantiate the bidder's claim or insufficient documentary proof thereof will be construed to mean that the bidder is forfeiting the evaluation points in that regard.
