DESCRIPTION	1. BACKGROUND
OF SERVICE	
	 The maintenance of specialized laboratory equipment plays an important role in the accuracy of water quality analyses and verification of results which may negatively affect the performance of water quality compliance. Therefore, the specialized laboratory equipment needs to be calibrated, serviced and maintained on a scheduled basis and also on an as and when required basis (emergency breakdown). As part of accreditation requirements, the ISO 17025 (South African National Standard: General requirements for the competence of testing and calibration laboratories) require calibration and maintenance records and systems to be in place at all times. Clause 6.4.7 of ISO 17025 states that – "the laboratory shall establish a calibration programme. Which shall be reviewed and adjusted as necessary in order to maintain confidence in the status of calibration." Clause 6.6.1 of ISO 17025 states that – "the laboratory activities are used, when such products and services: a) Are intended for incorporation into the laboratory's own activities b) Are provided, in part or in full, directly to the customer by the laboratory, as received from the external provider; c) Are used to support the operation of the laboratory. NOTE: Products can include, for example, measurement standards and equipment, auxiliary equipment, consumable materials and reference materials. Services can include, for example, calibration services, sampling services, testing services, facility and equipment maintenance services."
	Quality assurance checks, job cards and calibration certificates, will be required to be attached in order to process payments.
