- 32. All quotation prices must be inclusive of VAT for all registered VAT vendors.

REGISTRATION AS A VAT VENDOR

- 32.1. Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2. The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3. In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 32.4. The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.
- 33. All quotation prices must be in RSA currency and inclusive of Value Added Tax (VAT).
- 34. Quotations will be opened immediately after the closing date and time in a venue to be indicated.
- 35. No quotations will be accepted from persons in the service of State as it is defined in the Municipal Finance Management Act and Regulations.
- 36. The reinstatement and maintenance of paved and concrete sidewalks, all inclusive of materials, plant, base corrections, labour, disposal of waste to the dumping site and ensuring that all staff members abide by the safety requirements and that required traffic accommodation measures are implemented. PROJECT SPECIFICATIONS Repair and reinstatement of paved sidewalks, using paving bricks, all inclusive of materials, plant, base corrections, labour and disposal of waste to dumping site. • The unit of measure will be square metres (m²) The rate to include full compensation for the Contractor's charges for: the reinstatement of paved areas, using existing or new paving bricks, inclusive of provision for required material, tools and labour, transportation and offloading of spoil material at dumping site plus any dumping cost and ensuring that all staff members abide by the safety requirements and that required traffic accommodation measures are implemented. • Concrete works, thickness dependant on Engineers requirements, 20Mpa Concrete, using 19mm stone, with a 100mm slump, all inclusive of materials, plant and labour and disposing of rubble at dumping site. Treatment of weeds, using chemicals

The treatment of weeds requires the spraying of chemicals, containing the active ingredients: Glyphosate (480g/I SL). The Chemicals to be used to be pre-approved by Mogale City before commencement of any spraying works.

The rate per square meter to include full compensation for the bidders charges to treat weeds, using chemicals containing the active ingredients: Glyphosate (480g/I SL), mixed with water and applied with spraying equipment to affected areas and ensuing that all staff members abide by the safety requirements and required traffic accommodation measures are implemented.
