REGISTRATION AS A VAT VENDOR

- 32.1. Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2. The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3. In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.

SERVICE	1. INTRODUCTION
	The Human Immunodeficiency Virus (HIV) and Acquired Immunodeficiency Syndrome (AIDS) Management Section is located within the Community Services Department under Social Development Division. The section specializes on Ward Based door to door HIV/AIDS programme. This is one of the Government's preventative approaches used nationally to empower people about the epidemic of the virus and to them in turning knowledge into action. There are ninety-four (94) ward-based volunteers who are conducting education on HIV/AIDS in the thirty-nine (39) Wards of Mogale City. Through the door-to-door community education programme, the municipality has been able to reach out to 320 078 people during the 2024/ 2025 financial year. The section plans to train thirty-two (32) educators/volunteers in Peer Education
	Accredited training. It is a two (02) month course aimed at equipping learners, giving them an opportunity and exposure to learning more about community dynamics. It will also empower the educators/volunteers with relevant skills so that they can apply for better employment opportunities at Social Development, Department of Health, and other funded Non-Governmental Organizations (NGOs). The accredited training serves as an exit plan from the programme since the educators/volunteers have only two (02) years to be in the programme while receiving stipend.
	2. SCOPE OF WORK
	The successful service provider will be expected to conduct accredited training on Peer Education Accredited training to Mogale City Local Municipality ward-based educators/volunteers. The training should provide theoretical knowledge on basic counselling and provide practical learning for the learners. At the end of the training, the service provider is expected to assess the performance of the trainees and provide a competent certificate.
	The successful training service provider will be expected to conduct training to thirty-two (32) educators/volunteers of Mogale City Local Municipality (where they would be required to apply their acquired skills and knowledge after the training).
