- 31. The Municipality reserve the right to negotiate a fair market related price with recommended bidders after price quotations.
- 32. All quotation prices must be inclusive of VAT for all registered VAT vendors.

REGISTRATION AS A VAT VENDOR

- 32.1. Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2. The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3. In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 32.4. The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.
- 33. All quotation prices must be in RSA currency and inclusive of Value Added Tax (VAT).
- 34. Quotations will be opened immediately after the closing date and time in a venue to be indicated.
- 35. No quotations will be accepted from persons in the service of State as it is defined in the Municipal Finance Management Act and Regulations.
- 36. 	1. BACKGROUND	
	Surfaced roads within the rural areas do not have kerbs on the edges to protect the road for edge breaking. Some areas require edge restraints due to traffic crossing driving on the edge of the road and road curves and intersections. The intension of this RFQ is to address areas where edge breaking is a constant problem and causing the road surface to break.	
	2. PURPOSE	
	The purpose of this RFQ is for the appointment of a service provider on a quotation basis for the supply and installation of precast concrete kerbs and associated works for roads and stormwater maintenance works within Mogale City on an as and when required basis for a period of twelve (12) months for the Division: Roads and Transport.	
	3. SCOPE OF WORK	
	The installation of kerbs will be done on identified areas where edge break is prone to happening and where traffic needs to be directed with edge restraints.	
	3.1. METHOD OF WORKING	
	 The contractor must at all times exercise care while undertaking the work to ensure that trees, shrubs, hedges, flowers, etc on the pavements or private properties adjoining the work areas are not unnecessarily removed or negatively affected by the work. Should any damages occur as a result of negligence on the part of the Contractor, he/she shall be responsible for costs in this regard. The contract must ensure that adequate safety procedures are employed at all times when working on/next to public roads and storm water channels. The 	

jackets, gloves and dust masks.

contractor should also issue the required safety/ protective clothing, tools and traffic signs required to perform the work. Staff shall wear safety boots, reflective

- The Employer shall advise the Contractor on the location of the dump site. The Contractor shall be responsible for the dumping costs.
- Section of works, trenching and concrete works should be completed the same day to prevent further damage and possible accidents. Should it not be possible to fully reinstate the work area the same day, the Contractor must ensure that adequate protection measures are put in place avoid injuries to pedestrians and motorists.
- The Contractor will be held accountable for any claims arising out of injuries or damage to private property as a result of negligence or failure to provide adequate protection measures during the execution of the project.
- The Contractor must, at the commencement of the contract, submit the outline of his intended work schedule, for the approval of the Employer's representative
- Obstructions in waterways shall be removed when instructed by the Employer and the Contractor shall dispose of all material at designated spoil sites.
- When instructed by the Employer representative vegetation and debris removed shall be cut to size for transporting purposes.

3.2. PRELIMINARY AND GENERAL

The tendered rate includes full compensation for the Contractor's charges to complete the full task inclusive of Preliminary and General, labour, plant, material and all other cost associated with completion of the task. No additional payment will be made for any item in the task not listed but form part of the execution of the works. All material used to comply to the relevant SANS and COLTO specification.

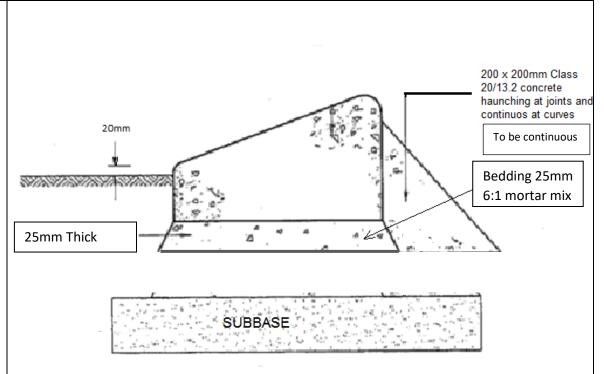
3.3. INSITU CAST CONCRETE WORKS:

- Saw cut exiting premix layer and base to specified depth, where required.
- Excavate area to depth of solid material as specified.
- Ensure vertical sides to the required depth / inclusive of shuttering.
- Compact in- situ material layers to 93% MOD AASHTO. Only hand compaction method allowed. Care must be taken not to disturb the surrounding compacted layer.
- Concrete is to be compacted into the mould by any method that will ensure dense concrete. (Vibration when required)
- Concrete to be class 25Mpa.
- The concrete to be wood floated.
- Concrete to be cured and protected against damage.
- Construction joint to be done every 5m.

3.4. INSTALLATION OF KERBING

Installation on precast kerbs of different size and shape will follow the same procedure.

- Earth works up to required depth.
- Bedding to be mortar, 6:1 sand/cement/water mixture, 25mm thick.
- Joints between kerbs should not be larger than 12mm. Joints to filled with 3:1 sand / cement / water mixture. The joints must be concaved with suitable tool. Ends of kerbs should be well moistened before jointing, and filled joints must be covered and kept moist for 48 hours.
- Haunching at every joint, Class 20/13.2 concrete. Continuous haunching on curves.
- Backfilling and compaction 1m behind kerbs. Compaction of in-situ materials in 150mm layers to 93% MOD AASHTO. (Walk behind Roller 90, minimum 4 x roller passes.
- Base material 2% cement stabilized compacted with 4 roller passes between kerb and base for correction.

3.5. DAY WORKS

The day work rate will be used in accordance with the General Conditions of Contract (GCC 2010) clause 37.2, for the use in determining payment for work which cannot be qualified in specific units in the schedule of quantities, or work ordered by the engineer during the project which was not foreseen at tender stage and for which no applicable rate exists in the schedule of quantities. The Contractor and the Engineer will agree on the method of recording the working hours prior to the commencement of the work. Any long period of idling at any one time which in the opinion of the Engineer or his representative is beyond that required for normal operating conditions will not be paid. An instruction regarding all work to be carried out under daywork in terms of Clause 37.2 of the General Conditions of Contract will be issued at the discretion of the Engineer. Non-working hours for any reason shall not be measured for payment. Labour day rates for MCLM is R186/day.

3.6. CONTRACTOR'S HEALTH AND SAFETY DECLARATION

In terms of Clause 4(4) of the OHSA 1993 Construction Regulations 2003 (referred to as "the regulations" hereafter), a contractor may only be appointed to perform construction work if the employer is satisfied that the contractor has the necessary competencies and resources to carry out the work safely in accordance with the Occupational Health and Safety act no 85 of 1993 and the OHSA 1993 Construction Regulations 2003.
