- 32. All quotation prices must be inclusive of VAT for all registered VAT vendors.

#### **REGISTRATION AS A VAT VENDOR**

- 32.1. Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2. The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3. In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 32.4. The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.
- 33. All quotation prices must be in RSA currency and inclusive of Value Added Tax (VAT).
- 34. Quotations will be opened immediately after the closing date and time in a venue to be indicated.

	1. BACKGROUND		
	Quotations to be invited from prospective service provider/s for the supply and delivery of effluent automatic composite sampler/s at wet industries within Mogale City Local Municipality.		
	The monitoring of industrial effluent or waste discharges from wet industries is implemented to prevent the pollution of water resources, i.e., streams, rivers, and the environment. It further minimizes the destruction and deterioration of the wastewater network and, therefore, improves the lifespan of the infrastructure assets. Hence, the quality and compliance of the industrial effluent should be monitored regularly, to ensure compliance to legislation.		
	The quality and compliance of the industrial effluent are determined based on MCLM Water Services Bylaws clause 100: Quality standards for the disposal of trade/industrial effluent, Annexure A: General rules regarding charges, and Annexure B: Limits and maximum concentration on certain substances. To determine the quality and compliance of the industrial effluent, specialized equipment for sample collection and volume determination is required.		
	The effluent composite auto-sampler is a vital tool for the collection of composite samples at wet industries. The effluent automatic composite sampler is used to ensure that the municipality collects more representative samples within a 24h period. Currently, the municipality collects grab samples at most of the wet industries due to the automatic composite autosampler/s not being available. Although grab samples are accepted, non-compliant discharges cannot be monitored 24 hours. Since wet industries are expected to comply for 24 hours, it is essential to monitor industries through composite samples. This is beneficial for both municipality and industries in terms of monitoring and effluent levy calculation purposes.		

Effluent automatic samplers are essential in environmental and industrial monitoring because they enable consistent, reliable, and representative sampling of wastewater or effluent discharges.

#### 1.1. Key reasons for automatic samplers:

#### 1.1.1. Consistent and Representative Sampling

- Reliable Data Collection: Automatic samplers can collect samples at regular intervals or specific flow conditions, ensuring consistent data collection that reflects the true quality and characteristics of the effluent.
- Capture Variability: Effluent quality can fluctuate over time due to changes in production, operations, or environmental conditions. An automatic sampler captures these variations more effectively than manual sampling, leading to more representative and accurate analysis.

#### 1.1.2. Compliance with Environmental Regulations

- Meeting Regulatory Requirements: Many regulatory agencies require
  continuous or periodic sampling of effluents to ensure compliance with
  discharge limits. Automatic samplers help meet these requirements by
  ensuring samples are collected according to the mandated frequency and
  method.
- Audit and Verification: Automatic sampling provides a reliable record of compliance, which is essential for audits and verification by regulatory bodies.
   This can prevent legal or financial penalties associated with non-compliance.

#### 1.1.3. Data Quality and Integrity

- **Minimized Human Error**: Automatic samplers reduce the possibility of human error in the sampling process, such as inconsistent timing or contamination, ensuring more reliable data.
- **Sample Preservation**: Many automatic samplers come with built-in refrigeration or preservation capabilities, which help maintain sample integrity by reducing degradation or chemical changes over time.

#### 1.1.4. Adaptability for Complex Monitoring Requirements

- Customizable Sampling Protocols: Automatic samplers can be programmed for various sampling strategies, such as time-based, flow-based, or event-based sampling. This flexibility allows for targeted monitoring, especially in facilities where effluent composition might change with operational activities.
- Integration with Monitoring Systems: Automatic samplers can often be integrated with other monitoring systems, such as flow meters and water quality sensors, providing a comprehensive view of effluent characteristics in real-time.

Due to the increased number of customer complaints and compliance with the Water Services By-law, it is important that effluent automatic composite sampler/s be installed at all major wet industries.

#### 2. SCOPE OF WORK

The bidder is required to supply, deliver, and install an effluent automatic composite sampler as listed in the pricing schedule.

#### 3. SPECIAL CONDITIONS

The following special conditions should be adhered to, and relevant documentation should be submitted as requested:

- 3.1. The municipality reserves the right to contact the contact person stated on the reference letter.

  - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
  - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

- 6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium<sup>3</sup> will not be construed as collusive bidding.
- 7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
  - (a) prices;
  - (b) geographical area where product or service will be rendered (market allocation)
  - (c) methods, factors or formulas used to calculate prices;
  - (d) the intention or decision to submit or not to submit, a bid;
  - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
  - (f) bidding with the intention not to win the bid.
- 8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
- 9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- <sup>3</sup> Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
  - 10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
