- 31. The Municipality reserve the right to negotiate a fair market related price with recommended bidders after price quotations.
- 32. All quotation prices must be inclusive of VAT for all registered VAT vendors.

REGISTRATION AS A VAT VENDOR

- 32.1 Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2 The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3 In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 32.4 The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.
- 33. All quotation prices must be in RSA currency and inclusive of Value Added Tax (VAT).
- 34. Quotations will be opened immediately after the closing date and time in a venue to be indicated.
- 35. No quotations will be accepted from persons in the service of State as it is defined in the Municipal Finance Management Act and Regulations.

	1. PURPOSE
	To request quotations for the procurement of brush cutter, chainsaw and pole pruner accessories required for the grass cutting and trees maintenance operations within municipal facilities and public spaces which mandated to the Biodiversity Management Division.
	2. BACKGROUND
	Parks Management subdivision is mandated with urban greening and parks maintenance which includes tree planting and maintenance (pruning, staking and watering) and grass cutting.
	Currently, the section is facing significant operational challenges due to the deterioration and shortage of essential accessories for brush cutters, chainsaws and pole pruners. Many of the guide bars, chains for chain saw and pole pruner are worn out. Gear box, sparks plugs, and bush cutter head are constantly breaking down which leads to inefficiency, and subsequently lead to:
	Reduced productivity – tree pruning and grass cutting operations take longer than scheduled. Sefety concerns the productivity – tree pruning and grass cutting operations take longer than scheduled.
	 Safety concerns – blunt or worn-out accessories increase the risk of accidents and damage to equipment.
	 Delays in service delivery – certain sites remain unattended due to lack of suitable tools.
	 Increased maintenance costs – forcing repeated servicing of old accessories instead of timely replacement.

Given the high demand for tree maintenance and grass cutting across municipal facilities and along public roads, the procurement of these accessories has become urgent to restore efficiency and ensure compliance with safety standards.

3. SCOPE OF WORK

Supply, delivery and off-loading of brush cutter, chainsaw and pole pruner accessories.
