### **REGISTRATION AS A VAT VENDOR**

- 32.1 Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2 The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3 In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.

	1. PURPOSE
	The purpose of this Quotation is to invite competent and suitably qualified entities/suppliers (hereinafter referred to as a Bidder) to bid for the supply, delivery and off-loading of skip bins to Mogale City Local Municipality
	2. SCOPE OF WORK
	The successful Bidder/s will be required to supply, delivery and offloading of skip bins to Mogale City Local Municipality (MCLM)
	3. TECHNICAL SPECIFICATION
	3.1. 6 m <sup>3</sup> STANDARD REFUSE CONTAINER
	3.1.1. CAPACITY
	The fluid level load capacity of the container will not be less than 6m <sup>3</sup> .
	3.1.2. MATERIAL
	The material used for fabrication would be commercial quality Mild Steel 430 MPa to 500 MPa UTS (Ultimate Tensile Strength) with the following through section dimensions: -
	<ul> <li>a) Container Side Plate Sections and Pressings 4.5 mm</li> <li>b) Container Floor Plate 5.0mm.</li> </ul>
	c) Container Lower Side Channels 3.0-4.6 Vastrap. d) Hinge Bar 50.0mm Diameter.

- e) Tip Bar 40.0mm Diameter
- f) Rear Hook Bar 25.0mm Diameter.
- g) Tip Bar Lugs 10.0mm.
- h) Tip Lug Backing Plate 10.0mm.

### 3.1.3. LIFTING LUG

The lifting lugs are of the machined type made from mild steel. The fitment of the lifting lugs is through a vertical "U" section stiffener whence they are fully welded to the stiffener and the side plate. The outer wedge section of the lifting lug is fitted with the Centre line of the wedge set at 45-degree angle, the small edge of the wedge uppermost.

### 3.1.4. REAR HOOKING BAR

The rear hooking bar consists of a 25mm diameter solid round bar formed into a "U" shape with an inner radius of not less than 69mm. The protruding portion of the hook bar angles forward 60 degrees from the horizontal plane, with the upper edge of the bar not less than 100mm from the container top edge. The leg section of the bar is fully welded to the container rear plate.

### **3.1.5. HINGE BAR**

The hinge bar consists of a 50mm diameter solid round bar, fitted to the forward sloping edge of the container and protruding an equal distance on either side of the bin. The upper edge of the hinge bar is fully welded to the front container plate along the full length of the plate and a reinforcing angle fitted to the lower edge space welded to both hinge bar and front plate. This reinforcing angle does not exceed the centre line point of the hinge bar.

### 3.1.6. TIPPING BAR

A 40mm diameter solid steel tip bar is space welded into four specially profiles 10mm thick steel brackets, which are in turn fully welded to a 10mm thick steel cross bearing plate 150mm wide x 1375mm long. This whole assembly is finally fully welded to the front plate. The clearance between the tip bar and the cross plate must be 70mm minimum.

### 3.1.7. CONTAINER CONSTRUCTION

The container is assembled in the following manner: ...

Folded corners, space welded inside and fully welded outside. Edge to edge construction is NOT acceptable. The bin side plates must taper inwards from 1655mm top inner width to 1516mm bottom inner width to enable the bins to be stacked one within the other. The container side plate must be constructed and reinforced in the following manner: -

### a. Side Section

The bin side upper channel forms a reinforced hollow box section by means of pressed steel sections, which overlap the side plate. The thickness of these sections is not less than 4.5mm. The lifting lug "U" section stiffener is a pressed section 145mm wide at the base tapering to 100mm wide at the top and is 50mm high. The thickness of these stiffeners must not be less than 4.5mm. The distance from the lifting lug centre to the bottom of the stiffener is 80mm thus allowing for the removal of the lifting links after stacking.

### b. Front Plate

The front plate has three edges pressed so that these edges wrap around the side plates and underneath the floor plate, thus providing extra strength to the joints.

### c. Rear Plate

The rear plate has three edges pressed so that these edges wrap around the side plates and underneath the floor plate, thus providing extra strength to the joints. The rear upper section is reinforced across the entire length on the inner side by means of a pressed steel section with a vertical "Y" axis "Ze" at least 11.5 cm<sup>3</sup>. This section, which has a minimum thickness of 4.5mml forms a hollow box after being fitted to the back plate. The rear lower section forms a 45-degree angle limiting the floor length of the container to 1855mm.

### d. Floor

The floor plate has a minimum thickness of 5.0mm and is reinforced by forming longitudinal corrugations consisting of at least twelve bends forming an equal pattern over the entire floor plate. The edges are pressed so that they wrap around the side plates thus reinforcing the joints.

### e. Lower Channel

The side plates are reinforced below the upright stiffeners by means of 100mm  $\times$  50mm pressed channels. These are pressed from 3, O — 4, 6 Vastrap plate.

### f. Chevron Bracket

A pressed bracket is welded to the front for the attachment of a chevron- The minimum thickness of this bracket is 1.6mm and it is 1220mm wide.

### a. Drain Holes

All containers have drain holes not less than 8cm<sup>2</sup> at each bottom corner of the container.

### h. Net Hooks

Ten net hooks, 10mm diameter, are welded to each container

#### 3.1.8. CHEVRONS

Two <u>fully reflective</u> chevrons 1200mm long x 200mm high are attached to the front and back plates respectively.

#### 3.1.9. REFLECTIVE TAPE

Yellow reflective tape is attached to all four top corners of the container.

### 3.1.10. **NUMBERS**

Steel plate numbers & letters of size 200mm high x 20mm width to be welded to both side of the skip painted with black enamel as follows for asset control purposes:

- The municipal and division abbreviation MCLM/IWM
- First 2 figures of the procurement financial year i.e.25-26
- Bin size
- Bin number



### **3.1.11. PAINTING**

The container must be cleaned of all foreign matter including weld splatter and shall be coated all over with one coat of lead free self-etching or equivalent. All exterior surfaces must then be coated with two coats lead free Golden Yellow industrial enamel

### **3.1.12. DRAWINGS**

Successful bidder to consult with the Department before manufacturing to confirm dimensions prior to manufacturing.



### 4. SPECIAL CONDITIONS

- 4.1. It is a mandatory condition that Bidders submit valid South African Bureau of Standards (SABS) (ISO 9001:2015 Quality Management Systems on steel products and related activities) certificate, In the case a bidder is not a manufacturer they must submit their manufacturer's valid certificate SABS (ISO 9001:2015 Quality Management Systems on steel products and related activities) certificate accompanied by a signed confirmation letter on the manufacturer's official letterhead, or a duly signed agreement, must be provided, confirming that the manufacturer will supply the bidder with the required skip bins and authorizing the bidder to use the manufacturer's certificate for this quotation.
- 4.2. Failure to submit the required documents for the applicable items will result in the automatic disqualification of the bid.

- 3. I am authorized by the bidder to sign this Certificate, and to submit the accompanying bid, on behalf of the bidder;
- 4. Each person whose signature appears on the accompanying bid has been authorized by the bidder to determine the terms of, and to sign, the bid, on behalf of the bidder;
- 5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
  - (a) has been requested to submit a bid in response to this bid invitation;
  - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
  - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder
- 6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor.

- However communication between partners in a joint venture or consortium<sup>3</sup> will not be construed as collusive bidding.
- 7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
  - (a) prices;
  - (b) geographical area where product or service will be rendered (market allocation)
  - (c) methods, factors or formulas used to calculate prices;
  - (d) the intention or decision to submit or not to submit, a bid;
  - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
  - (f) bidding with the intention not to win the bid.
- 8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
- 9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- <sup>3</sup> Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
  - 10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
