- 33.1. Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 33.2. The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 33.3. In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 33.4. The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.

BACKGROUND Mogale City Local Municipality (MCLM) hereby invites service provider/s for hire of TLB's to implement the annual project plans for Mogale City Local Municipality on an as and when required basis for a period of Six (6) months or until the value of the RFQ is reached. 2. SCOPE OF WORK The TLB is used on planned maintenance and construction projects as annually approved within the division's budgets and SDBIP targets. The utilization of the TLB's depends on the annual approved project plans for implementation. TLB's is used by various departments and divisions within the municipality for purposes such as the following but is not limited to: ➤ Maintenance of existing gravel road shoulders. ➤ Digging of trenches. ➤ Loading of material on to trucks. ➤ Maintenance of gravel shoulders. ➤ Cleaning of stormwater outlet systems and trenches. 3 GENERAL REQUIREMENTS WILL BE EXPECTED FROM THE APPOINTED SERVICE PROVIDER/S: 3.1.1 Skilled licensed plant operators. 3.1.2 TLB should be fitted with construction vehicle Amber Strobe Lights. 3.1.3 Delivery: TLB are expected to be delivered within 72hours of receiving an official order from the Municipality. 3.1.4 Plant should have adequate capacity in accordance with the manufacturer's specifications to perform the required work, are in good working condition, cause minimum dust, nuisance and pollution and are free from leaks. This is in line with the relevant Occupational Health and Safety (OHS) Act.

4. MEASUREMENT AND PAYMENT:

- 4.1.2 The supply, delivery and operation of plant shall be measured as indicated per item summarized in the schedule and stipulated in the Project Specifications and the Specifications for each operation, for each eight-hour (8hr) period or portion thereof.
- 4.1.3 Rates provided in the schedule shall be full rate inclusive of all duties and/or taxes and will be full rate which the client will pay for the provision of the plant, excluding value added tax (VAT).
- 4.1.4 Site Building: Not required at sites of operation.
- 4.1.5 Breakdown periods per plant/equipment will be limited to two hours (2hrs) maximum, thereafter the terms of conditions will be that replacement equipment must be provided by no later than the following working day.
- 4.1.6 The measurement of Standing Time shall be 50% of the Work Rate and is only for reason caused by the client or adverse weather conditions.
- 4.1.7 Transport costs for the supply, delivery and removal from site shall be paid once for delivery and once for removal to and from the client.
- 4.1.8 Transporting of plant between different sites will only be paid for plant that may not by law or not practically possible to move from site to site on its own power.
- 4.1.9 Payment will be made on condition that timesheets are co-signed by both operator and client representative daily to confirm hours worked.

5 INTERPRETATION:

5.1 Operators

Skilled plant operators must be employed, and any operator found to be unsuitable must, upon request by the client representative, be replaced immediately, or the machine will be put off hire. Once a machine is hired and on site, neither the machine nor the operator may be replaced without the consent of the client representative. All operators are to always have their valid unendorsed licenses on them.

5.2 Temporary Road Traffic Signs

Each **TLB** shall have two (2) TW336 road traffic signs with stands and four (4) 450mm orange cones and two (2) warning flags that will be the responsibility of the operator to position and remove before and after each day's work.
All the above is included in the rates.

5.3 Time of Operation (Normal Working Hours)

It will be endeavoured to work from 7:30 am until 12:30 and 13:00 until 16:00 -except where it is agreed between the Contractor and the employer's representative otherwise.
The works order shall be for 8(eight) hours per day unless otherwise requested.

5.4 Time of Operation (Overtime Working Hours)

Over time worked meaning hours after 16:00 during weekdays, working on Saturdays, Sundays and public holidays may be required. This will only be allowed on approval by the client's representative.

5.5 Conditions applying to payment

Payment will not be made on the following plant status during operating hours.

- (a) Servicing of the machine (including daily service checks);
- (b) Starting up of equipment and shutting down of equipment;
- (c) Mechanical breakdown, including the period while awaiting the arrival of spares;
- (d) No operator or driver;
- (e) Awaiting fuel or lubricants;

- (f) Inability of the machine(s) to work, in the opinion of the employers representative, due to the unavailability for any reason of an interdependent item of equipment hired from the same contractor;

7. Accommodation

The Service Provider shall arrange for own accommodation for operators, the Municipality is not liable to provide accommodation. Accommodation and security of plant in the various areas of operation is the responsibility of the service provider. The service provider will be responsible for the transportation of operators from and to the different daily sites of operation, in the municipal area of Mogale City.

8. Ground Engaging Tools (GET)

No GET with less than 15% tolerance from the manufacturer's specifications upon machine delivery will be allowed and must be replaced by the service provider. The employer will only after approval by the clients representative for replacement of the GET, cover the cost for GET.

9. Insurance

All plant must be fully insured for public liability and third-party risk by the service provider and **proof thereof must be provided before commencement of works.**

10. Delivery

- 10.1 TLB are expected to be delivered within 72hours of receiving a formal order from the Municipality. Failure to deliver on order within the timeframe as requested, penalties will be evoked in line with the Supplier Performance Monitoring and Evaluation Policy. The plant that is on standby must be delivered to site within two hours of request.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and

Bid rigging is, therefore, an agreement between competitors not to compete.
