### **REGISTRATION AS A VAT VENDOR**

- 32.1. Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2. The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3. In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 32.4. The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.
- 33. All quotation prices must be in RSA currency and inclusive of Value Added Tax (VAT).

## DESCRIPTION OF SERVICE

The use of pre-manufactured Gabion boxes and mattresses, filled with stone and placed next to embankments and rivers (attached pictures) to combat soil erosion, with the use of local labour from the affected communities, maximizing temporary job opportunities.

Specifications: COTO 2020 (DS) and SANS will apply.

### **Materials specifications**

#### Rock

Rock used as filling for gabion boxes or mattresses shall be clean, angular, hard unweathered and durable boulders, rock fragments or crushed rock. Rounded alluvial cobbles/boulders shall not be used. Rock containing aggressive minerals such as sodium oxide or calcium oxide shall not be used unless suitable corrosion resistant wire coatings are used. No rock fragment shall exceed the maximum size given in Table A12.6.5-1, and at least 85 % of the rocks shall be of a size equal to or above the average least dimension given.

### Wire

All wire used and dimensions for manufacturing the gabions and for tying during the construction of the gabions shall comply with the requirements of SANS 675 for class A heavy galvanized mild-steel wire.

### Galvanizing

All wire used in the making of gabions shall comply with SANS 1580 (zinc) or SANS 10244-2 table 2 (Zn95Al5).

### Wire mesh

Wire mesh shall comply with the requirements of SANS 1580.

### Geotextile shall comply with the requirements of SANS 10224, SANS

### **Construction Plant and additional Labour**

Provision has been made for additional equipment and labour which may be utilized, subject to pre-approval by the Employers representative, as per the pricing schedule under day works.

### Measurement and payment

#### **Foundation Trench Excavation:**

The tendered rates shall include full compensation for the excavation of the material to the required dimensions, lines, levels and grades, temporary timbering, shoring and strutting, including unavoidable over break, the trimming of the trenches and compacting the trench inverts, backfilling of over excavation and compacting the backfill, keeping excavations safe, dealing with any surface or subsurface water and the loading and disposal of the excess material as directed. The tendered rates shall also include full compensation for any other operations necessary for completing the work as specified, but excluding surface preparation for bedding the gabions. Excavation shall be done using conventional construction methods and/or labour enhanced construction methods as specified and measured.

### Surface preparation for bedding:

The unit of measurement for levelling and preparing surfaces for receiving the gabion boxes and mattresses shall be the square metre to the neat dimensions of revetments, aprons or wall foundations. The tendered rate shall include full compensation for excavating, filling any cavities with rock, and levelling the ground surface so as to be ready for receiving the gabion boxes tor retaining walls, aprons and revetments.

### Gabion boxes and matresses:

The tendered rates shall include full compensation for supplying all the materials, including rock fill, wire-mesh boxes, galvanizing, tying and connecting wires, loading, transporting and off-loading, the assembling and filling of the boxes, disposal of waste, and any other work necessary for constructing the gabions. Placing of rock by dumping shall not be allowed and the tendered rates shall also include full compensation for placing rock by means of hand labour.

### Bidim (geotextiles) - Class A4 bidim to be used

The tendered rate shall include full compensation for supplying the geotextiles, cutting, waste, placing, joining, overlapping, and securing the material in position.

### Preliminary and General (P&G's)



# TECHNICAL EVALUATION CRITERIA

The below mentioned criteria regarding Functionality is required for responsiveness and therefore eligibility for the next stage of evaluation. This is done to determine the ability of each bidder to successfully execute the contract according to specifications.

Non-compliant bidders will be rejected after this phase and not continue to price scoring.

These criteria shall only determine whether a quotation will further be evaluated and will not influence the points scored on Price.

- 1. Failure to achieve the **minimum total score of 19 points out of 25 points**, the bid will be deemed as non-compliant and will be rejected.
- 2. Failure to score the **minimum points** in <u>each</u> Criteria section (1,2 and 3) listed in the table below, the bid will be deemed as non-compliant and will be rejected.
