	This specification covers the application of hand applied surface slurry to roads. The rates quoted will include all materials, labour, transport, mixing and application of slurry within the jurisdiction area of Mogale City Local Municipality.
	The activities which are to be executed by hand to include:
	 Employing the required safety measures (barrier tape, signs, cones an personnel) to warn motorists.
	 Provide personnel with required safety equipment and PPE
	Cleaning, sweeping, clearing and compacting of area for application.
	Application of tack coat by brush.Mixing of Slurry
	 Placing of slurry and spreading with squeegees to required thickness.(8-12 or 6-8mm)
	 Finishing of the surface of slurry with hessing, Each layer shall be opened for traffic only after it has cured and is capable of carrying traffic. The Surfaced area is then smoothed and loose stones are removed by dragging the Hessing bags over the area. - 9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
