REGISTRATION AS A VAT VENDOR

- 32.1 Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2 The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3 In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 32.4 The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.
- 33. All quotation prices must be in RSA currency and inclusive of Value Added Tax (VAT).
- 34. Quotations will be opened immediately after the closing date and time in a venue to be indicated.

	1. BACKGROUND
	The Local Government Municipal systems Act (act 32 of 2000) prescribes under section 16 that a Municipality must develop a culture of municipal governance that compliments formal representative government with a system of participatory governance. Pursuant to this injunction, the council of Mogale City Local Municipality has adopted an integrated Development Policy (IDP) and budget process plan that seeks to ensure the consultation process with communities is heightened by reaching out to all corners of the city. As part of the process to compile the 2025/2026 Integrated Development Policy (IDP) and Budget, the Executive Mayor and members of the Mayoral Committee will embark on a series of public meetings with the aim of presenting the draft 2025/2026 IDP and Budget to communities. These meetings will assist the Municipality in soliciting input in the form of comments and suggestions from communities.

2. SCOPE OF WORK

The service provider will be required to deliver the following services:

- 2.1 Loud hailing service in twenty (20) wards of Kagiso, 3 wards of Munsieville and 7 wards of rural areas
- 2.2 The prospective bidder to provide their own transport with mounted loud hailing system
- 2.3 The bidder to ensure that the vehicle is equipped with a high-quality loud hailing system to relay clear messages that are easily understood by the communities
- 2.4 The loud hailing system/loudspeakers must transmit a distortion-free sound at a high volume and within a distance of about 200m or more.
- 2.5 The bidder to provide a Microphone
- 2.6 The bidder must use a live voice or recorded voice with clear message as provided by the public participation office.

- 7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
- 8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
- 9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- ³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
 - 10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
