- 32.1. Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 32.2. The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 32.3. In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 32.4. The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.

33. All quotation prices must be in RSA currency and inclusive of Value Added Tax (VAT).

- Educate the public about the historical and cultural significance of specific tourism offerings.
- Foster community engagement by involving residents and local Tourism stakeholders.
- A platform for Tourism Industry Business owners and SMME's to showcase and sell their services to the local community and visitors
- To give the Local Tourism SMMEs and the Youth the ability to access new and potential tourism markets.
- Improvement of Tourism trade and Networking opportunities for the local Tourism industry.
- Increasing the share of domestic visitors.
- To entrench a culture of travel amongst Mogale City Residents.
- Increasing tourism expenditure.
- Improving destination image and service excellence.
- Increasing the visitor footprint into the City.
- Develop the space for interaction between the Tourism products and the Consumers/Visitors both locally and nationally.
- To grow the event to be on the annual Tourism event in the Mogale City calendar
- To profile the variety of Tourism experiences that the Municipality has to offer to visitors.

## **4. SCOPE OF WORK**

The successful bidder shall be expected to carry out the following tasks and responsibilities, but not limited to:

### **▪ Event Conceptualisation & Planning**

- Work with the contracting authority to define the exhibition's objectives, theme, layout, and format (e.g. number of exhibitors, exhibition "mall" layout, footprint, flow, visitor numbers, dates).



- Determine and propose suitable venue(s), including floor layout plans, exhibitor spaces (size per exhibitor), common areas, signage/branding areas, visitor flow, accessibility, safety & emergency measures.
- Develop a detailed work plan / project plan including timelines, milestones (e.g. booking venue, exhibitor registration opening/closure, stand allocation, logistical arrangements, setup, exhibition days, dismantling).

▪ **Logistics & Operations**

- Manage all logistics: liaising with venue, organizing layout of stands/exhibitor booths, ensuring electricity/power supply, lighting, cleaning (before, during and after exhibition), stand maintenance, security, crowd management, signage, waste management, etc.
- Provide necessary infrastructure and services: e.g. furniture, display racks, tables, chairs, lighting, audio-visual equipment (if required), registration desks, visitor flow management. (Or coordinating with exhibitors for their special requirements if needed.)
- Organise exhibitor management: registration of SMMEs, assign stand/spaces, ensure compliance with exhibition regulations, manage exhibitor communication.

▪ **Branding and Communication Support**

- Provide event branding: signage, banners, promotional materials, exhibition layout graphics, exhibitor lists, directional signages, information desks, programmes (if required), etc.
- Manage visitor registration, entry control (if required), produce visitor badges or passes, manage exhibitor badges or credentials.
- Provide staff for event days: e.g. reception/registration staff, floor marshals, security, support staff, cleaning staff, technical staff (AV, electricity, maintenance) as needed.

▪ **Exhibition Execution & Management**

- Oversee setup of the exhibition (construction of stands/ booths, signage, branding, technical setup) **before** the event date. Ensure that by a specified “ready-by” date, the exhibition floor is fully prepared.
- Handle on-site management during the exhibition days: supervision, coordination, exhibitor and visitor support, logistics, problem-solving, maintenance, ensuring smooth operations.
- Manage dismantling/tear-down after the exhibition: ensure safe and timely removal of stands, cleaning of venue, restore venue to original condition, disposal of waste, return of rental items, etc.

▪ **Reporting & Post-Event Wrap-Up**

- Provide a post-event report summarizing the event: number of exhibitors, number of visitors, feedback (if relevant), summary of incidents or issues, lessons learned, recommendations for future exhibitions.

▪ **Compliance & Certifications**
