Non-VAT vendors do not have to include VAT in their quotation prices, however they must submit quotations for contracts that would, if successful, take their annual turnover above the threshold of R 1 million must include VAT in their price quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 31.2. The award of contract would be (for non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 31.3. In all instances where the bidder has excluded VAT from the prices quoted, if the bidder is successful, the letter of contract will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 31.4. The successful bidder will have to absorb the adverse financial implications of not including VAT in the price quoted.

PURPOSE</p> <p>The purpose of this request for quotation is for the supply and spraying of weed killer (herbicides) on an as and when required basis for a period of twelve (12) months.</p> <p>2. BACKGROUND</p> <p>The Division: Roads and Transport Services intends to appoint a service provider for the spraying of weed killer (chemicals) to prevent and combat weeds on roads, sidewalks, storm water channels etc.</p> <p>3. SCOPE OF WORK</p> <p>This scope includes the supply and spraying of weed killer(herbicides) on an as and when required basis, for a period of twelve (12) months, at various sites situated within the area of jurisdiction of the Mogale City Local Municipality, the minimum envisaged works to include:</p> <ul style="list-style-type: none"> • Spraying of +/- 300 Km road edges/ gutters (+/- 9ha), as and when required • Spraying of +/- 30 000m² walkways and paved areas (+/-3ha), as and when required • Spraying of +/- 6,0 km storm water channels (+/- 6 ha), as and when required • Any other area/quantity that may be required – (0,4 ha), Rate per m² <p>4. Method of working</p> <ul style="list-style-type: none"> • The service provider must at all times exercise care while undertaking the contract and ensure that trees, shrubs, hedges, flowers, etc. on the pavements or private properties adjoining the treated areas are not affected by root uptake or movement of the herbicide by wind, rain or transport by water and shall take precautions while working to prevent accidental contact with herbicide by children, animals or irresponsible persons. The service provider shall be responsible for costs in this regard. • Road edges and gutters to be sprayed at a maximum width of 300mm except for areas where cultivated and well-maintained sidewalks require only minimal treatment (specified width of 100mm or as specified away from the edge of the kerb line). In the event of damage, it must be repaired before the next payment will be made. For other areas the unit rate per m² will be applicable.

- The inside of the storm water channels must be treated but care must be taken so that the vegetation on the sides is not treated, as this can cause erosion.
- The contractor must, at the commencement of the contract, submit the outline, his intended program of working, for the approval of the Divisions representative.
- The program must include the chemicals to be used.
- The strength of the weed killer must correspond to the mixing requirements as laid down by the manufacturers and may also depend on the type of weed treated.
- The type of mixture used or changes thereto must be communicated to Mogale City's representative first for approval prior to the commencement of the project.
- Water usage for the spraying of poison, will be for the contractor's account and should therefore be included in the quoted rates. The necessary requirements for the sourcing of water from the Mogale City Water Reticulation Network to be discussed and agreed with the Utilities Management Services Department, before commencement of the works.
- Infested areas will be identified by the Municipality before commencement of spraying and any additional areas to be sprayed must be confirmed with the Municipality first. Areas sprayed without the consent from the Municipality will not be considered for payment.
- The first visit by the Contractor will be undertaken after receipt of an official order, with a follow up visit required after 21 days of the commencement date in order to determine the effectiveness for payment purposes. Should additional spraying be required to meet the required 95% effective weed control, the Contractor must commence with this work within 3 working days.

5. Specifications:

- Testing:
The client reserves the right to request samples when necessary and all Relevant Test Results of test made (Only on request).
- Effective Control:
A visible 95% effective weed control status must be visible on inspection at 21 days, if not; remedial spaying must be done by the contractor at his cost.
- Herbicide:
For the treatment of streets, sidewalks and paved areas, chemicals must contain the following described active ingredients:
Glyphosate (360 SC or SL) or: Glyphosate (540 SC or SL)
- Mixing and application rates:
The minimum prescribed mixing and application rates as indicated below:
 - **Chemical "A" Glyphosate 360 SC or SL**
Motorized Spray equipment
6 Litres Chemicals per 300 Litre water, apply 300 litres of the mix per hectare

Knapsack: 0,2 Litres per 10 Litres water (2%), apply 200 Liters of the mix per hectare
 - **Chemical "B" Glyphosate 540 SC or SL**
Motorized Spray equipment
4 Litres Chemicals per 200 Litre water, apply 200 litres of the mix per hectare

Knapsack: 0,225 Litres per 15 Litres water (1,5%), apply 200 Liters of the mix per hectare

6. Payment

The Contractor will be entitled to submit an invoice for payment as follows:

- 75% of completed work for spraying of chemicals, after the first visit.
Remaining 25% after a visible 95% effective weed control on inspection at 21 days after the first visit/application date. Should the required 95% effective weed control not be achieved, payment will not be made until such time as the contractor have performed the required remedial spaying at his cost.

7. Commencement of works.

The contractor, upon receipt of an official order, must submit the outline of the intended program within five (5) working days, for the approval of the Divisions representative. Once approval has been received from the Divisions representative, the works to commence within five (5) working days.

8. Special Conditions.

- Supply and apply appropriate herbicides for the control of weeds in designated areas.
- Ensure all herbicides used are approved by relevant authorities (e.g., Department of Agriculture, Environmental Affairs).
- Use calibrated spraying equipment operated by trained personnel.
- Conduct spraying at agreed intervals and respond to ad-hoc requests as needed.
- Ensure all work is done in compliance with applicable environmental, health, and safety regulations.
- Bidder appointed/ awarded the RFQ, Bidder must provide the valid COIDA letter of Good standing before the contract or starting work.

FUNCTIONALITY

TECHNICAL EVALUATION CRITERIA

- The above-mentioned criterion regarding functionality is required for responsiveness and therefore eligibility for the next stage of evaluation. This is being done to determine the ability of each bidder to successfully execute the contract according to specification.
- Non-compliant bidders will be disqualified after this phase and not continue to price scoring. These criteria shall only determine whether a bidder will further be evaluated and will not influence the points scored on price.
- Failure to score a minimum of **12 points out of 16 points** will lead to non-compliance and the bidder will be disqualified after this phase and not continue for price scoring.
- If any total minimum score for any criteria is zero, the bidder will be disqualified, even if the required minimum **12 points out of 16 points** are achieved.
- Scoring **zero (0)** points on any of the criteria/sub-criteria will lead to disqualification of a bidder.

5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder
6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
- (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ **Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.**

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
