COLTO Fine 6 % Penetration Grade Bitumen 40/50 to 60/70 or Cutback Bitumen MC 100/150 or similar. Cold mix asphalt supplied in 25 kg plastic bags. The aggregate and the binder must be pre-mixed, pre-batched and packed in bags, Maximum size stone of 6.7 mm.

8. BINDER TO BE USED TO COMPLY WITH SANS 4001-BT1 FOR:

Penetration Grade Bitumen (Grade 40/50 to 60/70) and **Cutback Bitumen** (MC 100/150 or similar). The Penetration Grade Bitumen shall be straight bitumen prepared from petroleum curds only. The bitumen shall have an ‘n-heptane-xylene equivalent less than 35% when subjected to the Spot test (Method 6.8, SANS 307). Approximate density for B12 Grade 50/70 of 0.9475 kg/litre.

The Aggregate Crushing Value of the aggregate stone must be less than 25%.

10. WORKABILITY:

The Cold Asphalt Premix must not be sensitive to climatic conditions and should flow freely from the bag and easily workable with a rake. Must not form lumps or chunks in the bag and should not require water or heating during the application.

11. SHELF- LIFE:

The Cold Asphalt Premix supplied must have a shelf life of at least six (6) months, for which written confirmation is required on delivery of each order to the Municipality.
