<b>DESCRIPTION OF GOODS/ SERVICES</b>	<p><b><u>SCOPE OF WORK</u></b></p> <p><b>1. BACKGROUND</b></p> <p>The Mogale City Local Municipality has taken over management of the Krugersdorp Game Reserve and has identified several opportunities to enhance revenue of the reserve and furthermore to make it more user friendly to residents and tourists. One of these identified opportunities is the development of a mountain bike trail through the reserve which can also serve the purpose to accommodate MTB races. A suitably experienced service provider is therefore required to develop/ construct these trails.</p> <p><b>2. DESCRIPTION OF THE SITE AND ACCESS</b></p> <p>The trails are to be developed within the Krugersdorp Game Reserve located towards the west of Krugersdorp.</p> <p><b>3. DETAILS OF CONTRACT</b></p> <p>The work to be performed under this Contract mainly consists of the following:</p> <ul style="list-style-type: none"> <li>• Development/ construction of flowing single track measuring no less than 600mm in width according to International Mountain Biking Association (IMBA) best practice in savannah grassland, <i>Celtis</i> woodland and rocky dolomite terrain.</li> <li>• Ensure that tracks follow natural contours as far as reasonably possible and reduce the risk of erosion and environmental degradation. Slopes and localities with a higher risk of erosion must be supported and backfilled with onsite rocks and materials. Trails must not channel water but must instead divert water off the trails. Trails must not exceed 50% of the natural incline of a hill.</li> </ul>
