- Remove all loose or peeling paint.
- Degrease entire exterior surfaces.
- · Remove all rust.
- With all rust removed apply a primer for steel containing Zinc Phosphate to all Exposed metal areas.
- Sand sound coating to provide a key for the next coat.
- Apply manufacturer's specification primer.
- Apply twin-pack Poly-Urethane final coat.
- Miniature substation base to be coated with black epoxy tar paint.
- Supply and paint stencil work on side panels.

 - Infrastructure, plant and equipment available to successfully execute this contract (3 points);
 - o Previous experience in this field as well as references (3 points).
 - Delivery period/lead time (4 points)

For purposes of comparison and in order to ensure meaningful evaluation, bidders are requested to furnish detailed information in substantiation of compliance to Functionality criteria mentioned. A bidder that scores less than 5 points in respect of functionality will be disqualified.




Figure 2 - Layout and dimensions for Type B mini-subs
