<b>DESCRIPTION OF SERVICES/ GOODS</b>	<p><b>SCOPE OF WORK</b></p> <p><b>1. NATURE OF CONTRACT</b></p> <p>Quotations are invited from suitable service providers for the supply and installation of three (3) jungle gyms in the day visitor area, lodge and Caravan Park at the Krugersdorp Game Reserve.</p> <p><b>2. SPECIFICATIONS</b></p> <p>Jungle Gym Specifications comprise of the following:</p> <ul style="list-style-type: none"> <li>• 3x Raised platforms (4m<sup>2</sup> each minimum) covered with shingle style roof and surrounded by safety balustrade.</li> <li>• Three platforms connected by two 4m hanging/suspension wooden bridges on chains.</li> <li>• 2x steel slides connected to two platforms.</li> <li>• “Tyre chimney” or “jacob’s ladder” connected to one platform</li> <li>• Rope ramp connected to one platform.</li> <li>• Four swing module connected to jungle gym.</li> <li>• 25m<sup>2</sup> silica sand box connected to jungle gym surrounded by kerb edge, excavated to 300mm and lined with geo-textile.</li> <li>• 2m x 2m x 2m spider web cube (gum pole cube frame covered in spider-web style rope work)</li> <li>• Structure to be treated wooden gum pole/saligna beams and supports.</li> </ul>

Play equipment shall comply with the following standards:

- All fasteners, connectors and covering devices should not loosen or be removable without the use of tools. Chains links on swings must be tag welded to prevent theft of chains.
- All fasteners, connectors, and covering devices that are exposed to the user should be smooth and should not be likely to cause laceration, penetration, or present a clothing entanglement hazard.
- Lock washers, self-locking nuts, or other locking means should be provided for all nuts and bolts to protect them from detachment. Hardware in moving joints should also be secured against unintentional or unauthorized loosening.
- All fasteners should be corrosion resistant and be selected to minimize corrosion of the materials they connect.
- Bearings or brushings used in moving joints should be easy to lubricate or be self - lubricating.
- All hooks, such as S-hooks and C-hooks, should be closed. A hook is considered closed if there is no gap or space greater than 3mm.
- The manufacturer should ensure that the users cannot ingest, inhale, or absorb potentially hazardous amounts of preservative chemicals or other treatments applied to the equipment as a result of contact with playground equipment.
- All paints and other similar finishes must meet the current American CPSC regulation for lead in paint (0.06% [600ppm] maximum lead by dry weight).
- Steel equipment shall be treated with red oxide rust prevention paint and be given two coats of hard wearing automotive paint
- Welding joints shall comply with BS EN ISO 15614-1: 2004 Specification and qualification of welding procedures for metallic materials. Welding procedure test.
- Wood used must withstand normal to excessive load bearing as may typically be found on a playground.

Playground equipment installation standards:

- All equipment to be installed to meet load bearing requirements.
- The installation must be certified by a Qualified Civil/Structural Engineer.
