3. SCOPE OF WORK

- **Minimum raw usable capacity of 100TB**, scalable, to accommodate the current 80TB usage with room for data growth, virtualization expansion, and system overhead.

Note:

Where SDS is utilized (e.g., S2D), traditional hardware RAID is not required and must not be implemented. If an alternative architecture is proposed, appropriate RAID levels must be specified and technically justified.

 - Point-in-time restores,
 - Backup deduplication, and
 - Local and/or cloud-based redundancy options.
